Candidate Registration / Certification Charges

All iPET Network qualifications are competitively priced based on the qualification level and size and include External Quality Assurance sampling. There are no annual fees or hidden charges for the approval or issuing of certificates. Our qualification prices generally follow the pricing structure illustrated in the table below, but please note this is to be used as a guide only due to the unique structure of some qualifications.

Supplementary Charges

Supplementary charges may apply relating to the below (list not exhaustive):

- Additional direct observations of Tutors/Assessors based on risk rating, number of learners and any standardisation required
- Additional systems training
- Additional audits required above the monitoring or reapproval audit

- Additional charges may apply for mandatory training where a centre has not acted upon actions set by IQA for repeated issues
- Additional training and standardisation, for example, due to malpractice, may incur additional fees at the half or full day rate of the IQA or EQA delivering the training
- Additional charges will be invoiced for each new qualification the Centre wishes to be approved for after initial approval

At iPET Network we offer additional services such as a learner e-portfolio platform and Internal Quality Assurance in some of our registration packages. Where applicable, packages will have access to any resources created by iPET Network for that qualification. Centres can also create their own materials provided they are mapped to the qualification criteria and approved by iPET Network in advance. As iPET Network offer these additional services when comparing our registration fees to other Awarding Organisations we suggest comparing the bronze registration fee and deduct further any annual costs and auditing fees.

All registration fees, supplementary and additional charges are subject to VAT at the standard rate.

General Invoicing

Upon receipt of the Application Form for Centre Approval, a non-refundable invoice will be raised and payment will be required via the Go Cardless Direct Debit system. Once payment has been received the application process will continue. Centres are invoiced at the point of registration for each Learner registered on iPET Network qualifications. Failure to pay within 14 days may result in access to services being removed. iPET Network use the Go Cardless direct debit system to offer an easy, admin-free payment method for Centres.

Learner Registration Deadlines

Learners must be registered with iPET Network within 10 working days of the start of the course or before any assessments are completed (whichever is earlier).

If a Learner fails to complete within the qualification registration duration, the following package costs will be charged for re-registration unless the Learner is eligible for an extension, please refer to the iPET Network Extensions of Registration Policy for further information.

External Quality Assurance (EQA) Remote Rolling Sampling

iPET Network's quality process for certification ensures that continuous sampling is carried out within a maximum of 8 weeks from a correct certificate claim date. This sampling activity is included in the Learner registration fee. Where there are Approved Centre concerns and additional sampling is required, iPET Network reserve the right to charge the Centre for the additional EQA activity as detailed below.

External Quality Assurance Audits

Approved Centres will EQA monitoring activity as standard every 18 months to 2 years, depending on the centre's level of experience. This is in addition to a mandatory annual self-assessment form that all Approved Centres must complete. Monitoring of Approved Centre Branches will be included in this activity.

If a Centre requests, or is requested by iPET Network, to undertake additional monitoring outside of the planned activity, iPET Network will charge the centre for this. iPET Network will confirm the time required for additional monitoring and fees relating to this activity before commencing.
